Terms & condition for Cathlab Tender :-

Outline the legal, financial, and procedural rules that bidders must follow to submit a valid proposal.

1. Eligibility Criteria: Bidders must prove financial stability, relevant past experience, and hold required legal registrations like GST, PAN, and Labour Licenses.
2. Submission fees & EMD: Bidders must submit a submission fee of Rs.2500/- which is nonrefundable. EMD of Rs. 1 lakh which is refundable .
(Cheque / DD of drawn on the name **Vivekanand Vaidyak Pratishthan**)
3. Bid Validity: Proposals must remain valid and open for acceptance for a set period, typically 15 days from the opening date.
4. Submission Deadline: Bids must be delivered to the address before the exact closing date and time; late submissions are automatically rejected.
5. Pricing and Taxes: Quoted rates must be clear, fixed, and inclusive of all applicable taxes, freight, and delivery charges unless stated otherwise.
6. Completion Period and Penalties: The contractor must install, finish the work & give commissioning of cardiac cathlab within the strict timeframe i.e. 3 months from the purchase order. Failing which liquidated damages or financial penalties apply.
7. Warranty & CMC: Cathlab needs minimum 1 year warranty & 2 years CMC.
8. Payment Terms: Payments are processed according to project milestones or after final inspection, verification, and acceptance by the buyer.
 - A. 10 % amount will be given at the time of purchase order after finalisation all the term & conditions
 - B. Second instalment of 80% amount will be given upon delivery of cathlab machine at the consignee location and submission of requisite documents such as tax invoice, delivery challan/ receiving copy.
 - C. Third instalment of 10% of the amount will be given upon installation & commissioning the cathlab machine.
